a. Legislative Committee Report - The House upheld Governor Burgum's veto of SB2360. HB1205 has been signed and now we need to figure out how this affects libraries.

The keynote speakers' rooms have been comped, and there is a reduced rate for the rooms for the Presidential trifecta. Proposals have started - reminder that committees must send in proposals.
