Treasurer's Report: No report at this time.

Old Business:

- a. 2023 Conference Update Conference Credit has been approved. There is still no flight information for Deborah Caldwell-Stone. The possibility of a poster session was raised, but there is no space available. Plans are well in hand the schedule needs to be finalized. The conference Board meeting will include a Zoom component NDSL will bring their Owl.

- c. Honorary Membership Award The Membership Committee approved the nomination. Mariah Ralston motioned to accept the nomination of an honorary membership for Iris Swedlund and send it to the general membership for approval. Will Martin seconded. 11 in favor, none opposed or abstaining.
- d. October Summit Non-fiscal sponsorship does not come with a table or a ticket. NDLA has not sponsored other organizations. Discussion of whether the LGBTQ2S+ committee could raise funds for sponsorship or if that would be construed as organizational support. Will Martin motioned to approve \$50 as a table fee and not a sponsorship. Seconded by Tammy Kruger. 10 in favor, 1 absent, none opposed or abstaining. Will Martin motioned to initiate a conversation with the membership at the conference regarding organization sponsorships. James Murphy seconded. Motion was withdrawn and sent to the Finance Committee.

### **New Business:**

- b. Putting the Flickertail Awards under the SLAYS Committee Flickertail is currently a subcommittee and the co-chairs would like to be done. Discussion of previous and current chair of SLAYS committee being the chairs for the Flickertail Award. SLAYS can discuss this at conference.
- c. Intellectual Freedom Committee Banned Books Week Public Engagement The committee would like to do Public Engagement/Outreach, but are not sure what they can do as a committee. After some discussion, they will send a letter to Kerrianne Boetcher to distribute as NDLA President.
- d. LGBTQ2S+ Committee Local Resources Printout The committee has a local resources handout they would like to be customized for NDLA and put it on their website. The Communication policy is currently lax about within the organization,

- but nothing prevents this. The Bylaws and Policy Committee will reexamine the policy for further clarification.
- e. Conference schedule Aaron Stefanich asked about the conference schedule being posted. Will Martin agreed to check on it and get something up.
